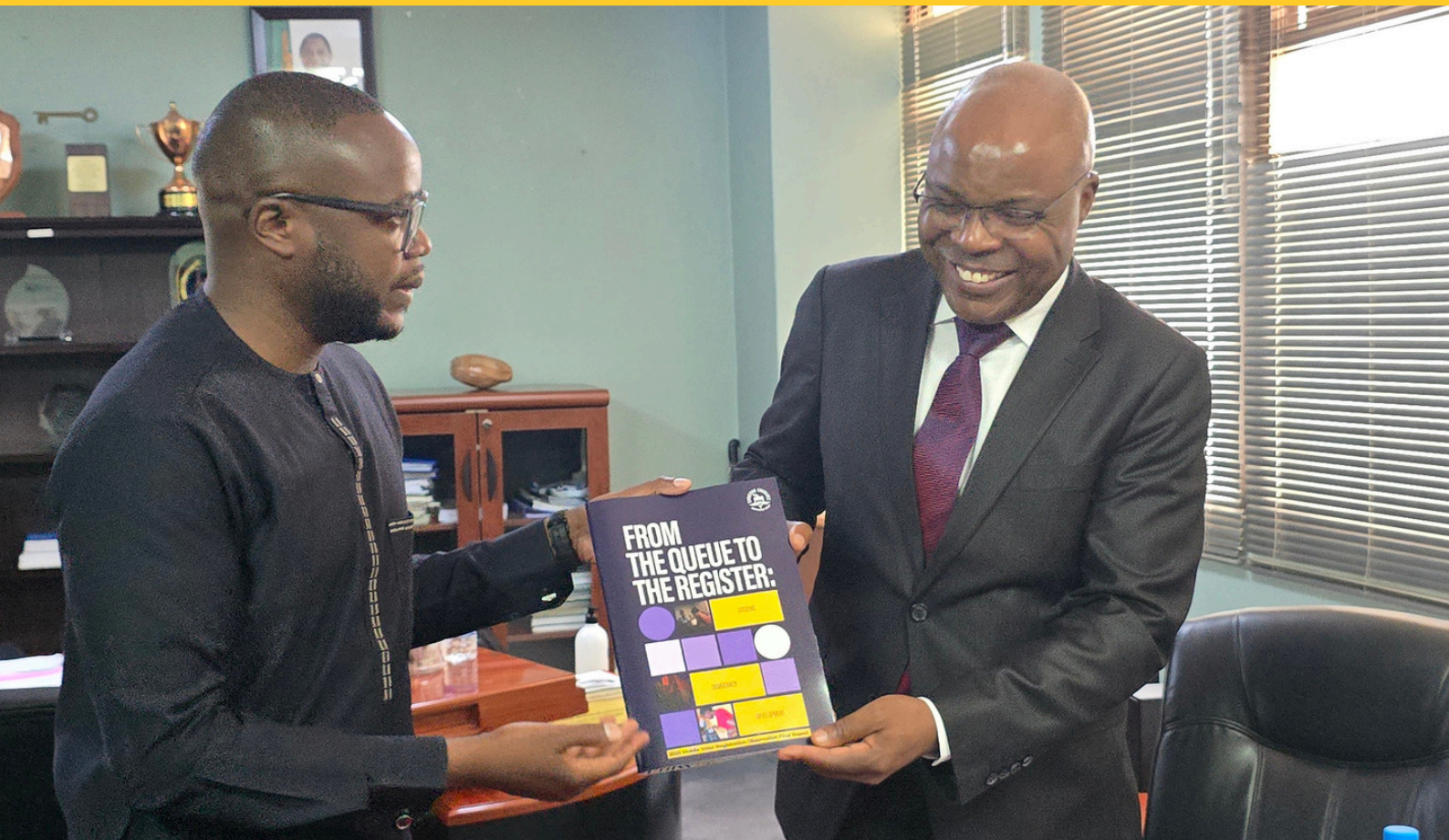

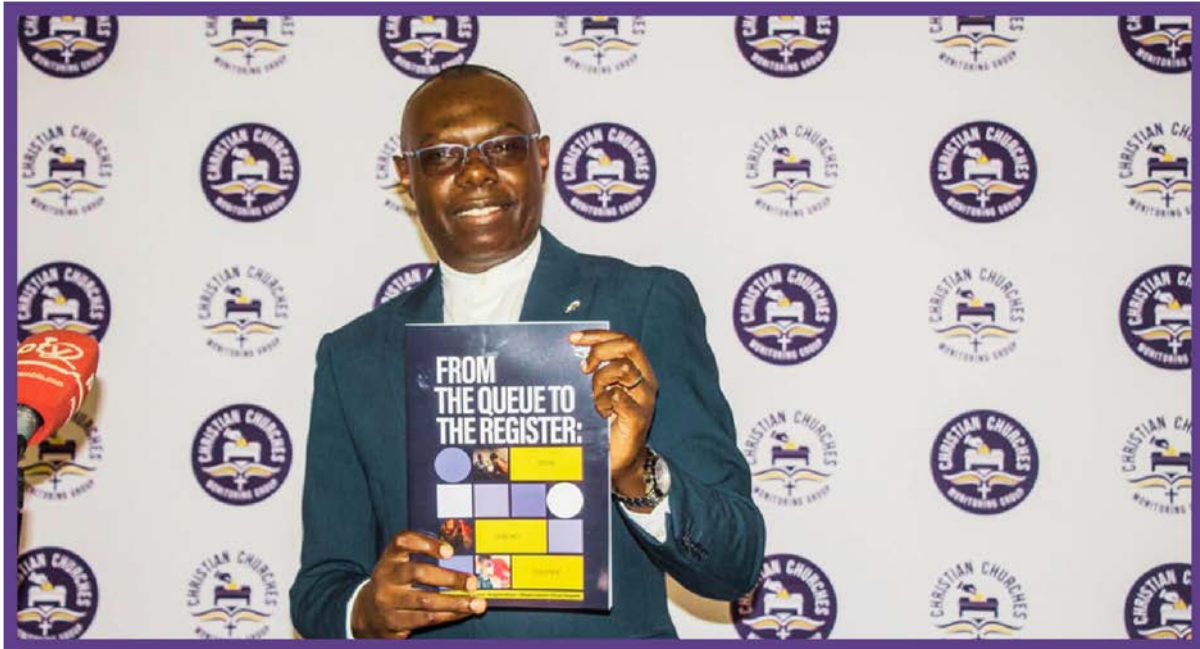

From the QUEUE TO THE REGISTER! CCMG launches VRO Final Report

CCMG released its final report on the 2025 Mobile Voter Registration Exercise, highlighting both progress and persistent challenges ahead of the 2026 General Election. The full report was officially launched on 30 January during a stakeholder engagement meeting with partners and Civil Society Organizations, and was also presented to key stakeholders, including the Electoral Commission of Zambia (ECZ).

The report notes improvements while identifying key gaps such as delayed opening of centres, staffing shortages, limited backup equipment, and barriers to accessibility. Concerns around transparency, including restricted access to registration data in some centres, were also raised.

Overall, CCMG concludes that while the process largely adhered to required standards, greater coordination, inclusiveness, and transparency are essential to strengthen public confidence and ensure a more effective electoral process.

CCMG Launches the Election Recommendation Implementation Tracker

On 3 March 2026, the CCMG officially launched the Election Recommendation Implementation Tracker (ERIT), an innovative web-based platform developed to monitor progress on electoral reform recommendations in Zambia.



The platform serves as a centralized accountability tool, enabling stakeholders to track implementation efforts, identify gaps, and support evidence-based decision making ahead of the 2026 General Election. By strengthening transparency and promoting institutional accountability, ERIT represents a significant step toward more responsive and credible electoral governance.

CCMG hosts the Electoral Integrity Summit in Lusaka



The Christian Churches Monitoring Group, in partnership with the African Election Observers Network (AfEONet), successfully hosted the second Electoral Integrity in Africa Summit in Lusaka from 11–12 November 2025. Held under the theme “*Defending Democracy and Reclaiming Civic Space*,” the summit convened 148 participants from over 50 organizations across Africa and beyond, including representatives from government, civil society, and regional bodies.

The convening created a critical platform to reflect on the state of democracy on the continent, with discussions focusing on shrinking civic space, electoral integrity challenges, and the growing influence of illicit political finance. Participants also explored the opportunities and risks presented by artificial intelligence and digital technologies in electoral processes.

As co-host, CCMG played a central role in advancing dialogue on citizen-led election observation as a key pillar of democratic accountability. The summit reaffirmed the importance of protecting civic actors and strengthening collaboration among observer groups across the continent.

The summit concluded with the adoption of a communique outlining key recommendations, including:

- Strengthening electoral transparency and accountability
- Protecting civic and democratic space
- Enhancing post-election reform mechanisms
- Promoting youth, women, and inclusive participation
- Regulating political finance and addressing illicit financial flows

Leveraging technology responsibly while safeguarding rights

The outcomes of the summit mark a significant step toward reinforcing democratic resilience and advancing African-led solutions to electoral challenges.

CCMG remains committed to promoting credible elections, strengthening citizen participation, and supporting democratic governance across Zambia and the African continent.

CCMG Calls for Peaceful Elections

As Zambia approaches the 2026 General Election, CCMG calls on all stakeholders, citizens, political parties, civil society, and state institutions to play their part in safeguarding a peaceful, credible, and inclusive election. Eligible citizens are encouraged to verify their registration details and actively participate, while political parties and candidates must uphold the Electoral Code of Conduct and reject all forms of violence, misinformation, and intimidation. Together, through collective responsibility and active engagement, we can uphold democratic values and ensure that the 2026 election reflect the true will of the people.



The Christian Churches Monitoring Group (CCMG) is a consortium of the Council of Churches in Zambia, Evangelical Fellowship of Zambia and the Zambia Conference of Catholic Bishops. Established on November 28, 2014, its primary objective was to oversee the presidential elections on January 20, 2015. Since then, CCMG has been actively involved in monitoring the entire electoral process.
